1. Ms. Ramos received 18,930 shares of restricted stock on 7/2/2007 under the ITT 2003 Equity Incentive Plan. 6,000 shares vested on 7/2/2009; 2,918 shares were subject to a three-year restriction period and vested on 7/2/2010; and 6,000 shares vest on 7/2/2011. Vesting of these shares is accelerated upon termination of employment by the Company other than for cause. In addition, 4,012 shares were subject to a three-year restriction period and vested on 7/2/2010. 2,642 shares represent the tax withholdings on vested shares.
