- The 7,792 includes 3,556 shares of restricted stock awarded on March 6, 2006 under the ITT 2003 Equity Incentive Plan. The 3,556 shares awarded March 6, 2006 are subject to a three-year restriction. Mr. Hill also owns 4,236 shares directly.
- Options granted under the 1994 ITT Incentive Stock Plan exercisable upon the earlier of 1/3 on the first anniversary date; 1/3 on the second anniversary date and 1/3 on the third anniversary date or a 25% increase in the closing price above the option price on the NYSE for 10 consecutive trading days. These options became fully exercisable on 4/18/2002.
